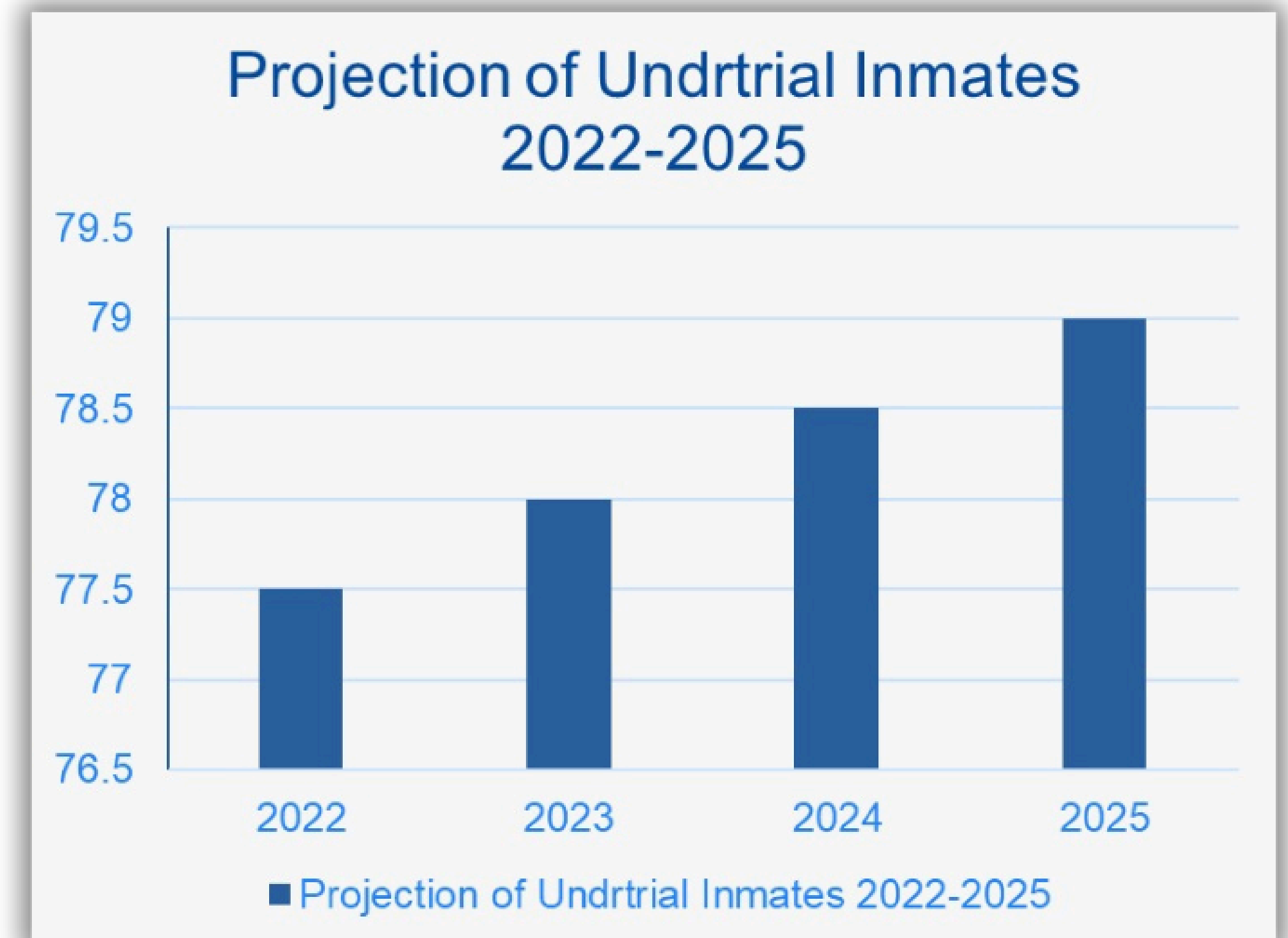
Why Equallex Exists



Every day in India, justice is denied not because of guilt or innocence, but because of poverty and power.

- 3 out of 4 prisoners are undertrials, many jailed simply because they cannot afford bail.
- Survivors of violent crimes often face intimidation when perpetrators are politically or socially powerful.
- Public interest concerns—from environmental justice to housing rights—remain buried under bureaucratic red tape.

Equallex was created to bridge the gap between law and lives to make sure justice reaches those who need it most.

Our work aligns directly with SDG 16: Peace, Justice & Strong Institutions, ensuring:

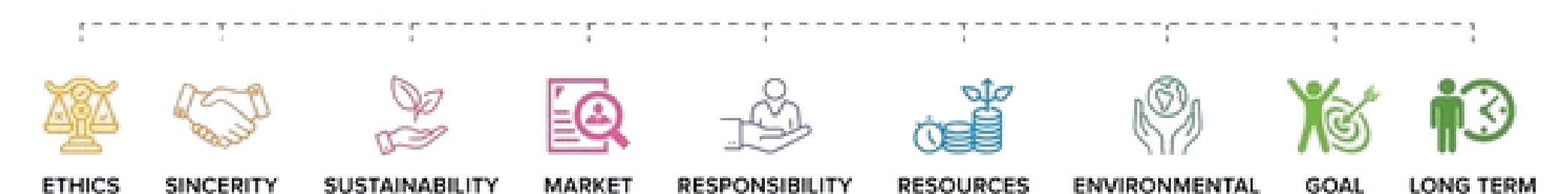
- Protection of human rights

The Undertrial Crisis



India's justice system is overflowing with undertrial prisoners:

- 75.8% of prisoners in 2022 were undertrials.
- Thousands spend years behind bars without conviction.
- Bail is denied, not because of crime severity, but because of poverty and lack of legal aid.

Equallex's Response:

- Bail Clinics across states
- Filing Section 436A petitions for prolonged detentions
- Early representation to stop injustice at the start





Justice Denied by Cost

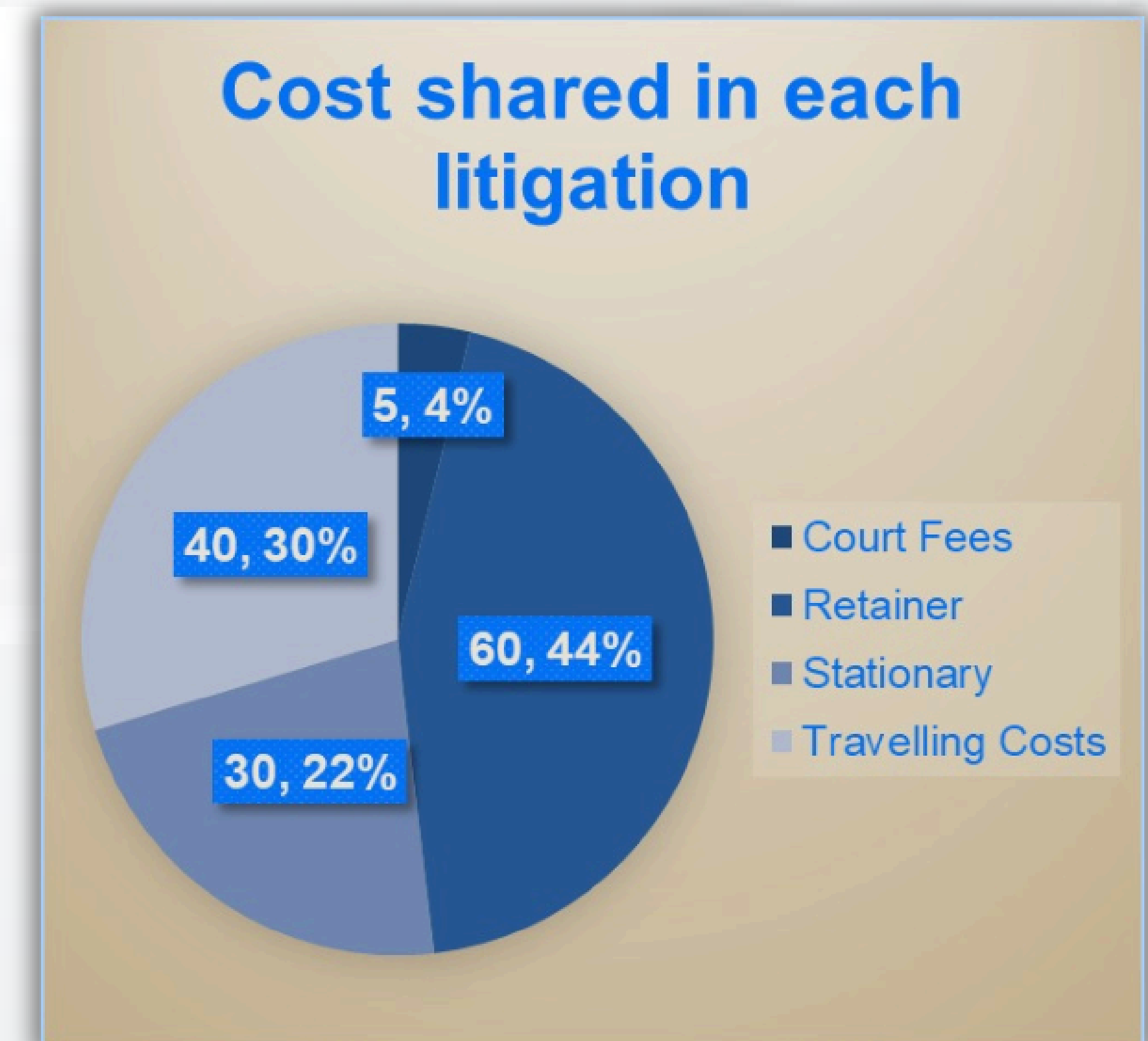


For millions, justice is simply too expensive.

- High legal fees exclude the poor.
- Public defenders are overburdened.
- The result: wrongful convictions and missed appeals.

Equallex's Defense Desks:

- Free representation for those who cannot pay
- Case preparation and appeals support
- Legal literacy workshops so communities understand their rights





Public Interest, Private Neglect



Issues that affect millions environmental degradation, unsafe housing, wrongful detention often receive little legal attention.

Equallex steps in where others won't:

- Filing strategic PILs
- Running community legal clinics

- Policy reform that benefits thousands
- Greater corporate reputation through visible social justice work





Justice Delayed = Lives Derailed



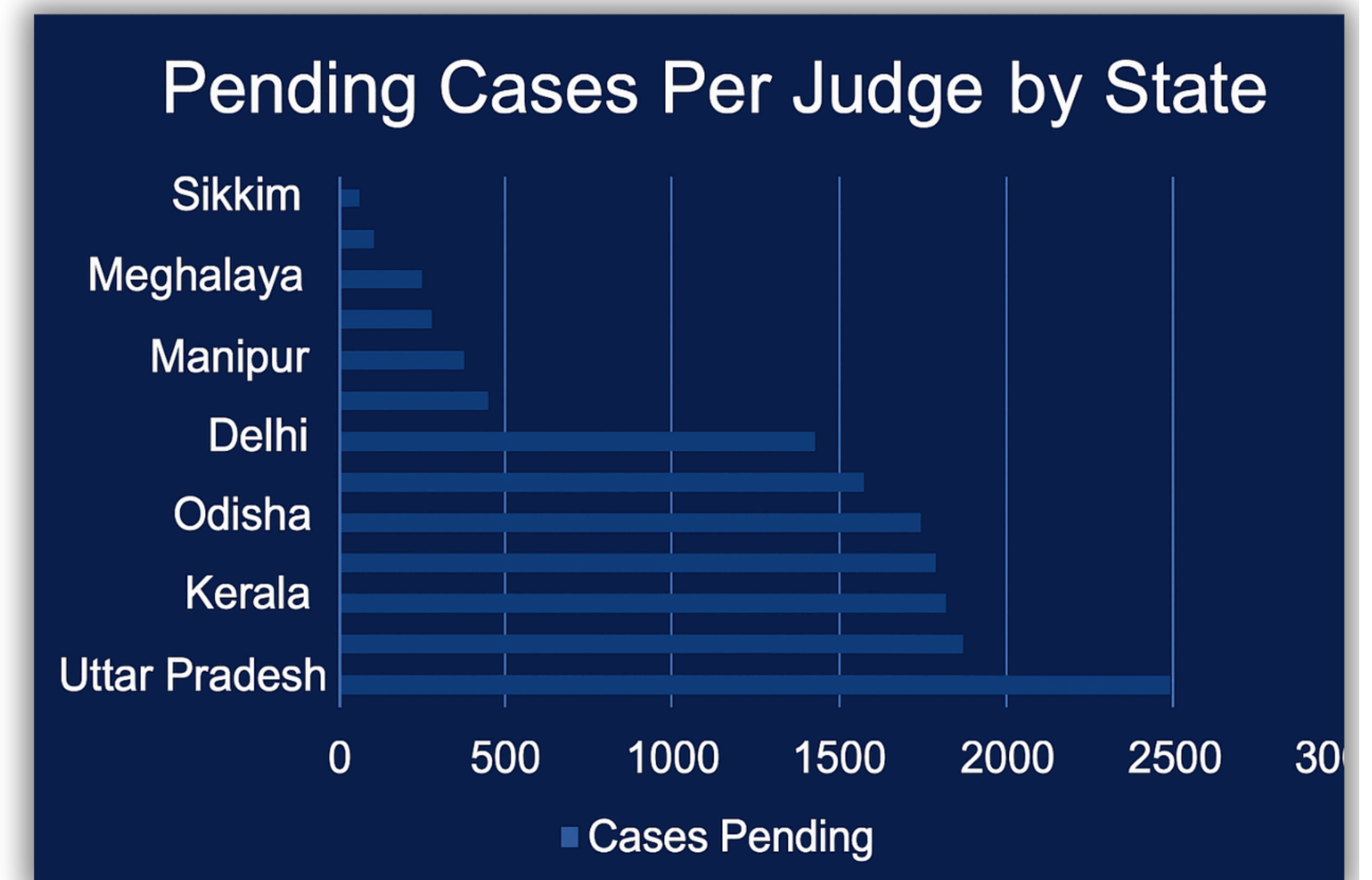
India's courts are drowning in pending cases. Long adjournments ruin lives:

- Survivors are left vulnerable
- Accused individuals lose years without a trial

Equallex's Approach:

- Case tracking through technology
- Time-bound litigation strategies
- Court monitoring to push for accountability

Survivors vs. Power

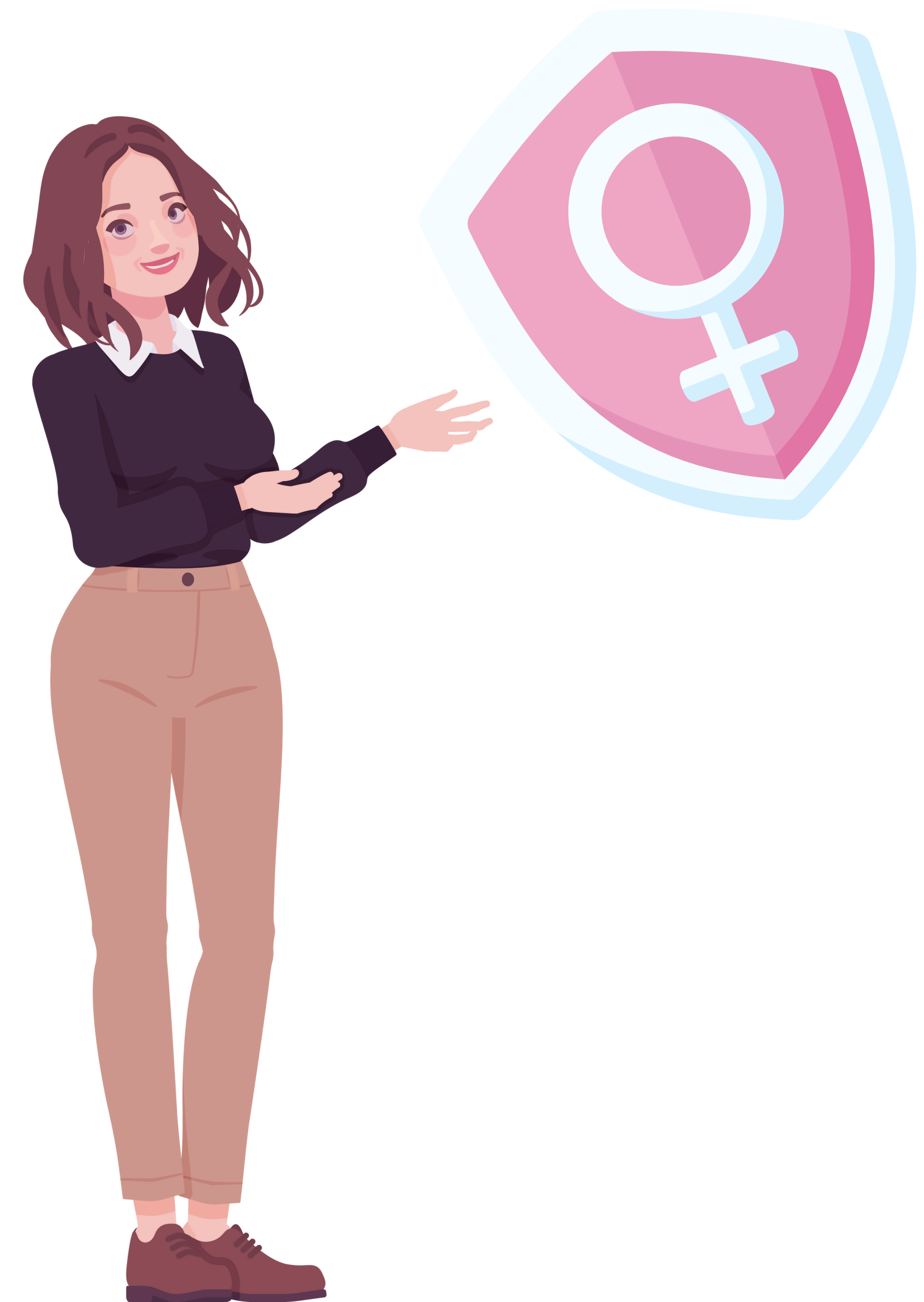


Survivors of crimes like rape, torture, and murder often face threats when the accused are powerful.

- Protection petitions in court

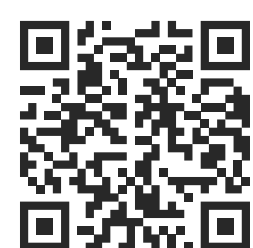
